## Section 4 First Aid

### EMERGENCY OVERVIEW

DANGER. Combustible liquid. May be harmful or fatal if swallowed. Aspiration hazard if swallowed. Causes skin irritation and eye damage. May cause respiratory irritation.

EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing.
